The International Peoples College Student Code of Conduct





As representatives of Magna Vitae at the International Peoples College (IPC), all students are expected to uphold standards of conduct that promote learning, respect and personal integrity.

The following code of conduct outlines the expectations for student behaviour at all times:

Academic Integrity:

- All academic work must be the result of the student's own effort.
- Plagiarism, cheating, fabrication, and other forms of academic dishonesty are not allowed.
- Respectful Behaviour:
- \cdot Students shall treat all members of the college community with respect, courtesy and professionalism.
- Discrimination, harassment, intimidation, and bullying based on race, gender, religion, sexual orientation, disability, or any other characteristic are strictly prohibited.
- Disruptive behaviour that interferes with the rights of others to learn and participate in academic activities will not be tolerated.

· Alcohol and Drugs:

- The possession, use, distribution, or sale of alcohol and illegal drugs on campus or at college-sponsored events is prohibited.
- Students of legal drinking age must consume alcohol responsibly and in accordance with college policies and applicable laws.

· Residential Life:

• Students living on campus housing must abide by the rules and regulations outlined in the Residential Life Handbook.

• Quiet hours, guest policies, cleanliness standards, and other guidelines must be respected to maintain a positive living environment for all residents.

Safety and Security:

• Students shall comply with all safety protocols and procedures designed to protect the well-being of the college community.

• Threats, violence, possession of weapons, or any behaviour that poses a risk to the safety of others will result in immediate disciplinary action.

• Technology Usage:

 The use of college-provided technology resources, including computers, internet access, and email, must be in accordance with college policies and for educational purposes only.
 Unauthorised access, hacking, or distribution of malicious software is strictly prohibited.

Community Engagement:

Students are encouraged to actively participate in campus activities, clubs, and organisations that promote personal growth, leadership, and community service.
Contributions to a positive campus culture through involvement in extracurricular activities are valued, supported and encouraged.

Financial Responsibilities:

• Students are responsible for understanding and meeting their personal financial obligations whilst studying at the IPC. All direct costs to the college, including tuition, fees, food and accommodation will be covered by Magna Vitae.

Compliance and Accountability:

• Students are expected to comply with all college policies, rules, and regulations, as well as local, state, and federal laws.

• Violations of the student code of conduct will be subject to disciplinary action, including warnings, probation, suspension, or expulsion, depending on the severity of the offense.

By enrolling at the International Peoples College students agree to abide by the provisions outlined in this code of conduct. Upholding these standards is essential to fostering a safe and inclusive, learning environment for all members of the college community. Specific policies in relation to the IPC itself, and day to day study shall be covered as part of the College's induction.
